

Persecution of Christians in the World: A Call to Prayer and Reflection

In recent times, our Christian siblings have endured unimaginable suffering due to their unwavering faith in Christ. One heartbreaking example occurred on Sunday, July 28, 2025, when terrorists attacked a Catholic church in Congo, entering during a time of prayer and worship and targeting the gathered congregation. In a devastating act of violence, 38 innocent lives were taken, and in another nearby town, 5 more Christians were murdered. Such attacks are heartbreaking, yet they are part of a larger pattern of persecution that continues to unfold in various parts of the world.

The persecution of Christians is not a new phenomenon. From age to age, the faithful have faced oppression, hatred, and violence simply because of their belief in Jesus Christ. The Bible speaks clearly about this reality. In the book of Revelation, the apostle John writes to the churches, acknowledging their struggles but also encouraging them to endure, knowing that victory is assured through Christ. Revelation 2:10 says, "Do not fear what you are about to suffer. Behold, the devil is about to throw some of you into prison, that you may be tested, and for ten days you will have tribulation. Be faithful unto death, and I will give you the crown of life."

This passage reflects the enduring truth that persecution is a part of the Christian journey. Throughout history, from the early martyrs of the Church to present-day victims of religious violence, believers have faced immense challenges. The apostle Paul, too, speaks of the suffering that accompanies following Christ in Philippians 1:29: "For it has been granted to you that for the sake of Christ you should not only believe in him but also suffer for his sake." Jesus Himself warned His disciples in John 15:20, "Remember the word that I said to you: 'A servant is not greater than his master.' If they persecuted me, they will also persecute you." Persecution, therefore, is not a new or unique occurrence—it is a continuous reality for Christians around the world.



However, Jesus also provides comfort in the midst of these trials. In John 16:33, He reassures us, saying, "I have said these things to you, that in me you may have peace. In the world you will have tribulation. But take heart; I have overcome the world." Despite the immense suffering that Christians face, we are reminded that Jesus has already won the victory over sin, death, and the world.

In the face of such persecution, it is crucial for us as a Church to respond with compassion and solidarity. As Christians, we must continually pray for our siblings who face violence and oppression for their faith in Congo, Syria, Palestine, Egypt, and other places where Christians are persecuted.

At the same time, let us also give thanks for the relative peace we enjoy in countries like the United States, where, though we may face challenges in expressing our faith publicly, we are not subjected to the violent persecution that many of our global family members experience.

In conclusion, the persecution of Christians remains a painful reality in our world today. As believers, we know that Jesus has overcome the world, and we are called to remain steadfast in our faith, no matter the trials we face.

Reflections from Pine Ridge A Journey of Witness, Compassion, and Hope

Linda and Joe Rehorst shared powerful reflections from their mission trip to the Pine Ridge Reconciliation Center in South Dakota, a ministry supported by the ELCA.

A pivotal moment was their encounter with Basil, a 92-year-old Native American veteran. Despite the injustice that his ancestors faced by the US government, he engaged in military service. Basil recounted the



traumatic history of Native communities—children taken to boarding schools where they lost their language, identity, and were often abused. His message of forgiveness was profound: healing could only come by letting go of hate, even amidst the current crises of addiction and suicide.

Linda and Joe witnessed firsthand the deep cycles of poverty and addiction plaguing the reservation. Grandparents often care for grandchildren because parents struggle with substance abuse. Many elders forgo nursing care to preserve their benefits and keep their families intact. Though a well-equipped nursing home exists, most elders remain at home, prioritizing family stability over their health.

They also met Virgil, a 44-year-old Native man educated at Berkeley, who returned to teach sustainable gardening and assist the elderly. He shared personal pain, including the loss of a child to suicide, but continues to mentor youth and model resilience. His story embodied hope and the importance of returning educated leaders to the community.

Challenges on the reservation are immense. Although alcohol is banned, drugs are accessible through cartels, and addiction rates remain high. Employment is limited, and drug screening prevents many from securing jobs. Economic reliance on federal aid from 19th-century treaties remains a stark reality. According to the treaty, the government was obligated to provide food through the seventh generation. Now that the seventh generation has arrived, there is growing concern within the community about the potential loss of this government aid.

Yet, spiritual strength endures. Native songs, smudging rituals, and prayers in the Lakota language continue to sustain the people's identity and faith. Linda and Joe were deeply moved by the community's commitment to cultural and spiritual practices, even after centuries of forced assimilation.

The legacy of injustice remains visible. Boarding schools that stripped children of their heritage operated well into the 1970s. While no abuse continues today, the presence of a Catholic school on the reservation stirred personal emotions for Linda.

Their trip was not a mission of service, but a journey of emergence that included listening, learning, and spiritual awakening. It deepened their awareness of systemic injustice, and the strength of a people determined to survive with dignity and faith.

Corruption and inadequate justice continue to plague Native communities. Linda and Joe heard from a courageous woman working with Missing and Murdered Indigenous Women (MMIW). She explained how tribal law offers limited authority, and federal agents cannot intervene due to historic treaties. As a result, crimes often go unpunished. Some perpetrators of murder received sentences as short as three months before returning to the community. Despite facing threats, she persists in her mission to bring justice and healing to grieving families.

A spiritual highlight of the trip was the visit to Wounded Knee, site of the 1890 massacre of over 200 Lakota men, women, and children. As their guide shared the story in Lakota, the sky darkened, and wind howled. Thunder struck vertically as they stood around the mass grave, sensing a sacred presence. Later, at the Reconciliation Center, they created dreamcatchers and reflected on the experience, many moved to tears.



The Pine Ridge Reconciliation Center provides essential services. To encourage independence, it offers one meal daily and job opportunities. Children enjoy weekly gatherings with crafts and treats. Pastor Dan, along with staff like Tony and Abraham, help run the ministry. Abraham, once a student from Florida, left college to serve the community and founded the homeless shelter. Though attacked several times, he completed his education and now manages daily operations with commitment and compassion.

Linda and Joe also encountered powerful Native art. One disabled artist paints buffalo representing the four races and sacred directions. His work reflects Lakota theology and the story of White Buffalo Woman—a symbol of divine instruction, peace, and unity. They purchased his artwork to support his livelihood and raise awareness in their own community.

Despite systemic obstacles, the Rehorsts found signs of hope. People like Virgil, Tony, and Abraham embody change through education, mentorship, and service. The nursing home is a dignified space for elders, and the Reconciliation Center is a beacon of care and resilience. Progress is slow but present, fueled by the dedication of a few faithful individuals.

The experience left a lasting emotional and spiritual impact on Linda and Joe. They returned with a deeper understanding of injustice and a renewed desire to advocate and support the community. They recognized that healing requires more than charity—it demands education, cultural respect, trauma-informed care, and long-term relationships grounded in trust. Most importantly, their trip reshaped their understanding of mission. True service begins with listening, humility, and walking alongside others with empathy and solidarity.

Members Present: Treasurer Laurie Olson, Mary Jane Hartley, Pennie Linna, and Fern Furhmann, Financial Secretary Pat Westphal, and Jason Blank

Opened with a Prayer.

Reviewed current account balances through end of June 2025. June's giving to current monthly expenses was \$13,318.44 giving and expenses of \$6,562.26. The difference was \$6,756.18. Laurie noted that we have not received the invoice for Pastor's June salary/benefits which is \$8,000+.

Year-to-date: Spending=\$81,853.94 and Giving=\$84,459.49 with a net of \$2,605.55.

Total Associated Bank checking has a balance of \$237,950.06 which includes \$129,992.29 allocated to designated accounts and \$107,957.77 for current operating. Additionally, \$171,911.13 in the Thrivent money market and \$1,038.77 in Thrivent TIPS account and \$57,298.52 in the ELCA Mission Investment Fund.

The 2nd quarter financial statements have been provided to members by Financial Secretary Pat Westphal. Statements have been in the narthex for pick up. The remaining statements will be mailed out.

Laurie noted that the council discussed emphasis on connecting passions/talents to ministry as a goal. We reviewed examples of resources to use as part of this year's stewardship program. The stewardship program will be discussed at our August meeting, including setting the date for Stewardship Sunday. Team members were asked to research ideas/themes for this year's program.

Laurie has suggested that Finance & Stewardship establish a Gift Acceptance Policy, to assist in the accepting, acknowledging, what type of gifts, use, approving, etc. Examples were reviewed. Laurie will draft a policy with further discussion at August's meeting.

The Endowment Ministry Team received an application for funding (\$1,250) from Pennie Linna and the 8 other individuals who went to the Pine Ridge Reconciliation Center earlier this month. They requested funds to help pay for the trip. They put the application in the Endowment Team mailbox, but did not inform me that it was

there, and I really don't look in those boxes except when it is time to distribute a Council Packet, so I didn't see it until mid-June, right before the team was getting ready to leave. I consulted with Treasurer Laurie Olson, and she said the money could be approved after the trip had taken place as the individuals going on the trip had a church credit card they will use for gas and food costs as well as any other expenses, and the grant, if approved, could be used to pay those credit charges.

Getting the Endowment Ministry Team together to discuss this proposal quickly was problematic, so I contacted members and explained the grant request to the other team members and asked for their input. We unanimously voted to approve the request.

Current balance of the Endowment Fund as of June 30, 2025 is \$200,551.96, earning \$2,725.66 over the last month.

New Business:

God's Work Our Hands: As part of "God's Work Our Hands" (September 7th), St. Mark's has been invited to participate in a "Sleep in Heavenly Peace" bunk bed build with other Neenah ELCA churches. This event will take the place of a project at Linwood Place. (Looking to do a project later in the fall at Linwood Place.) Pastor Tabitha from Gloria Dei is still working out details, including obtaining a grant. Each participating church will need to cover the cost of supplies for five bunk beds at a cost of \$1,250. The Sleep in Heavenly Peace organization is responsible for distributing the beds. After the discussion, it was decided we will use SCRIP money to cover the cost. Tammie oversees the RaiseRight/SCRIP program and is agreement with the use of SCRIP funds. MSC to use SCRIP funds to cover the cost of the supplies by Dawn Jones/Tammie Kersten.

Acceptance for Donations: Ellen LaMarche and Karrington Hartley. Ellen LaMarche has agreed to fund the cost of the LED lighting and technology needs. Karrington Hartley is funding a bike rack in honor of her mom, Jane Hartley. MSC to accept these gifts from Ellen and Karrington by Jason Blank/Dawn Jones.

Laurie noted the Finance & Stewardship Team is developing an Acceptance of Gift Policy/Procedure which will include how gifts are accepted, approved, acknowledged, etc.

Fellowship Hall Mural:

Sophia Kersten has sketched a design for a mural project for the west wall in the Fellowship Hall. This is a project of the Youth Ministry Team with supplies covered by the Youth Activity Fund. As we move forward, a date(s) will be set to work on the project. All youth will be invited to be a part of the painting project. Hoping to get this done in the next couple weeks. The council reviewed Sophia's sketch.

ESTHER Support Letter: Dawn informed the council that misinformation has been given to ESTHER, regarding St. Mark's support of their agency and mission. To clear up this misinformation, a letter will be sent to ESTHER Fox Valley confirming St. Mark's continued participation and support.

MSC to approve the letter of support of ESTHER by Dawn Jones/JT Rose.

Covenant for Ministry Teams & Council: An additional statement has been added to the Covenant for Ministry Teams & Council document, which was originally approved in 2023. The addition states: "All who show interest in serving are to be welcomed and included, as each person brings unique gifts to the ministry of God." A memo will go out to all ministry teams informing them of this addition and the importance of finding a place for all who wish to participate.

Orphan Grain Train +





